

一、如何取得公費 COVID-19 快篩包？

How do I obtain a free COVID-19 rapid test kit?

快篩試劑由機場 CDC 人員確認移工手機之居家檢疫系統填報結果，即由 CDC 人員當場發放給移工。

CDC personnel will hand out free COVID-19 test kits at the airport after checking the health statement and home quarantine electronic system on the cellphones of newly arrived foreign workers.

二、公費 COVID-19 快篩試劑使用時間點？

When should free COVID-19 rapid tests be used?

檢疫及自主健康管理期間共計 17 日，需自行配合使用 5 次家用快篩試劑：

第 1 次：入境日起後第 3 天

第 2 次：入境日起後第 5 天

第 3 次：入境日起後第 7 天

第 4 次：入境日起後第 13 天

第 5 次：入境日起後第 16-17 天

Quarantine and self health management last for a total of 17 days. During this period five COVID-19 rapid tests should be administered:

First test: On the third day after arriving in Taiwan

Second test: On the fifth day after arriving in Taiwan

Third test: On the seventh day after arriving in Taiwan

Fourth test: On the 13th day after arriving in Taiwan

Fifth test: On the 16th-17th day after arriving in Taiwan

四、如果使用快篩呈「陽性」反應應如何做？

If the COVID-19 rapid test comes back “positive” how should I respond?

快篩結果 2 條線為陽性，如為陽性，請主動與仲介或雇主聯繫，配合當地衛生局後續採檢及醫療。

If the result of the COVID-19 rapid test is that the two lines are positive, immediately contact your employer or labor broker and cooperate with follow up testing and medical treatment arranged by the local health authorities.

五、溫馨提醒：

Friendly reminder:

- 在檢疫期間如果發現試劑有破損時，請聯絡仲介或雇主提供快篩試劑。

If during the quarantine period you find that any of the rapid tests are damaged, contact your labor broker or employer to provide replacements

- 檢疫期間請勿離開房間(例如：不可出房門聊天、裝水)

Do not leave your room during the quarantine period (for example do not leave it to chat with others or get water)

- 如違反檢疫規定，處新臺幣 10 萬至 100 萬元罰鍰

Violations of quarantine regulations will result in a fine of NT\$100,000 to NT\$1 million

- 如有任何需要請聯繫檢疫所人員/服務人員或可致電 1955 專線
